TRUCKING DRIVES THE ECONOMY



COMPETITIVE WAGES

In 2024, trucking industry wages paid in Louisiana averaged **\$56,539**, and exceeded **\$5.3 billion** in total.

Heavy and tractor-trailer truck drivers held **26,260** jobs in Louisiana in 2024. The national average annual salary of an over-the-road truck driver is **\$75,144**.

TRANSPORTING THE ESSENTIALS

62.6 % of manufactured tonnage transported by trucks in Louisiana.

That's **170,450** tons per day

78.2 % of communities in the state depend exclusively on trucks to move their goods.



THE INDUSTRY

The trucking industry in Louisiana paid approximately

\$512 million
in federal and state roadway taxes

The industry paid **38%** of all taxes owed by Louisiana motorists ...



... despite trucks representing only **14%** of vehicle miles traveled in the state.

As of January 2026, a typical five-axle tractor-semitrailer combination paid highway user fees and taxes of ...
